Frequently Asked Questions

Storm Water Technical Assistance Program

What is SD1's storm water technical assistance program?

As part of the regional storm water program, SD1 has employed the technical assistance program to help communities and co-permittees with storm water drainage issues. This program applies when the extent of the problem is not clear, and the possible solutions and the degree of their effectiveness is not apparent. The program applies to private property drainage issues or public drainage issues where a co-permittee is exploring the effectiveness of various alternatives. Under this program, SD1 will evaluate storm-water-related issues and develop planning-level solutions. These are not detailed design plans, but rather concept-level solutions. Under this program SD1 will evaluate the severity of the issue, determine any system deficiencies and develop alternatives based on these findings. Additionally, SD1 will evaluate whether any of the concept-level solutions would qualify for other SD1 storm water programs, such as Public Infrastructure Cost-Share, Storm Water Assistance Cost-Share or Public Culvert Cost-Share.

Who may apply?

All SD1 co-permittees are eligible to participate in the technical assistance program. Property owners in need of technical assistance for storm water drainage issues must contact their city or county to participate in the program. SD1 will accept requests for technical assistance only from co-permittees. The amount of funding available for this program is determined each fiscal year as part of SD1's budgeting process.

How can my agency apply?

Applications are available at www.sd1.org under documents and forms tab under "storm water" and "miscellaneous forms." In general, projects are funded on a first-come, first-served basis while funds are available.
